I am writing regarding your email response (see below) regarding three ACLU-NJ OPRA requests. You requested additional time (until June 24, 2013) to respond to certain aspects of our requests.

The ACLU-NJ has no objection to your request for an extension regarding Items 1 and 4 in our request dated May 10, 2013, as well as Item 4 in our May 8, 2013 OPRA Request #2.

However, you also requested an extension regarding Item 3 in our May 8, 2013 OPRA Request #2 as well as Item 3 in our request dated May 10, 2013. Those specific requests were for "All scoring sheets and other records used to determine the eligibility of, approval or denial of funding to, and amount awarded to [applicants]." The scoring sheets are easily-identifiable, easily-obtainable items that should, upon request, be provided in short order. To the extent that our requests for "other such records [other than the scoring sheets] used or relied upon to determine the eligibility for and amount awarded to each of these applicants" would require additional time, we do not object to your request for an extension regarding that specific aspect of the requests.
