VERIFIED COMPLAINT

PLAINTIFF HARRY SCHEELER, as and for his Verified Complaint, herein alleges as follows:

PRELIMINARY STATEMENT

- 1. This is a summary action brought pursuant to the Open Public Records Act ("OPRA") N.J.S.A. 47:1A-1.1 et seq., and the common law right of access.
- 2. This action arises out of the failure of multiple New Jersey public agencies to provide access to government records requested pursuant to OPRA and the common law.
- 3. Plaintiff, Harry Scheeler ("Plaintiff"), is an open government activist who, among his other activities, conducts audits of public agencies' compliance with OPRA and other open government laws. To that end, Plaintiff files OPRA requests with numerous public agencies specifically seeking copies of prior OPRA requests submitted to the agency during a specified period of time, and the agency's response thereto ("OPRA Records").
- 4. OPRA Records are identifiable government records, and absent a showing of exemption, privilege or undue burden on the public agency, the OPRA Records must be produced pursuant to OPRA.
- 5. For the past several years, Plaintiff has filed OPRA requests seeking these OPRA Records, and public agencies have granted Plaintiff access. See Exhibit A.
- 6. It is common practice for both citizens and news media to request the OPRA requests of third parties and even the records provided to third parties pursuant to those requests. Moreover, under OPRA's federal counterpart, the Freedom of Information Act ("FOIA"), logs of prior requests are considered government records subject to disclosure.
- 7. In late 2013 and early 2014, numerous OPRA requests were made by news media and others to obtain internal communications and other documents from New Jersey

executive agencies regarding the closure of lanes on the George Washington Bridge, an issue now commonly known as "Bridgegate." In January 2014, after the public release of government records related to Bridgegate, Gov. Chris Christie held a news conference and announced that a senior staff member from the Office of the Governor and his campaign manager had been fired. Shortly after those events, New Jersey executive agencies began denying Plaintiff and others access to OPRA Records. See Exhibit B; see also J.K. Trotter, "Gov. Christie's office is looking out for reporters' scoops . . . by refusing to release its FOIA log, MUCKROCK (May 2, 2014, 12:40 PM), https://www.muckrock.com/news/archives/2014/mar/24/new-jersey-foia-log-christie-denial/ (describing a similar denial of access to OPRA Records by an online journalist) (attached hereto as Exhibit C).

- 8. The reasons cited by the executive agencies for the denial of his OPRA requests are specious, including inapplicable dicta from a 2005 Appellate Division decision and the unsupported notions that OPRA affords confidentiality to third parties' OPRA requests and protection in order to prevent competition, and that Plaintiff is in some sense a competitor.
- 9. Contrary to these agency positions, which are completely unsupported by law, the purpose of OPRA "is to maximize public knowledge about public affairs in order to ensure an informed citizenry and to minimize the evils inherent in a secluded process." Mason v. City of Hoboken, 196 N.J. 51, 65 (2008) (quoting Asbury Park Press v. Ocean County Prosecutor's Office, 374 N.J. Super. 312, 329 (Law Div. 2004)). Accordingly, access to government records by citizens such as Plaintiff who seek to ensure New Jersey public agencies' compliance with applicable laws is the foundation of OPRA. See Fair Share Housing Center, Inc. v. New Jersey State League of Municipalities, 207 N.J. 489, 502 (2011) ("Those who enacted OPRA understood that knowledge is power in a democracy, and that without access

to information contained in records maintained by public agencies citizens cannot monitor the operation of our government or hold public officials accountable for their actions.").

10. The denial of Plaintiff's requests for OPRA Records is a violation of OPRA and the common law right of access.

PARTIES AND JURISDICTION

- 11. Plaintiff is a resident of Woodbine, New Jersey. . Plaintiff is vested with a statutory and common law right of access to government records.
- 12. Defendant Office of the Governor is a public agency subject to the requirements of OPRA, and the common law right of access. See N.J.S.A. 47:1A-1.
- 13. Defendant Andrew J. McNally ("McNally") is the Custodian of Records for the Office of the Governor. McNally is named herein in his official capacity.
- 14. Defendant N.J. Motor Vehicles Commission ("MVC") is a public agency subject to the requirements of OPRA, and the common law right of access. See N.J.S.A. 47:1A-1.
- 15. Defendant Joseph F. Bruno ("Bruno") is the Custodian of Records for the MVC. Bruno is named herein in his official capacity.
- 16. Defendant N.J. Department of Law and Public Safety, Division of Alcoholic Beverage Control ("ABC") is a public agency subject to the requirements of OPRA, and the common law right of access. See N.J.S.A. 47:1A-1.
- 17. Defendant Bruce J. Solomon ("Solomon") is the Custodian of Records for the ABC. Solomon is named herein in his official capacity.

- 18. Defendant N.J. Department of Military and Veterans Affairs ("MVA") is a public agency subject to the requirements of OPRA, and the common law right of access. <u>See N.J.S.A.</u> 47:1A-1.
- 19. Defendant Mark A. Preston ("Preston") is the Custodian of Records for the MVA. Preston is named herein in his official capacity.
- 20. Defendant N.J. Department of the Treasury ("Treasury") is a public agency subject to the requirements of OPRA, and the common law right of access. See N.J.S.A. 47:1A-1.
- 21. Defendant Cynthia Jablonski ("Jablonski") is the Custodian of Records for the Treasury. Jablonski is named herein in her official capacity.
- 22. Defendant N.J. Department of Law and Public Safety, Division of Consumer Affairs ("DCA") is a public agency subject to the requirements of OPRA, and the common law right of access. <u>See N.J.S.A.</u> 47:1A-1.
- 23. Defendant Robert J. Campanelli ("Campanelli") is the Custodian of Records for the DCA. Campanelli is named herein in his official capacity.
- 24. Defendant N.J. Department of Education, Division of Chief of Staff ("DoE") is a public agency subject to the requirements of OPRA, and the common law right of access. See N.J.S.A. 47:1A-1.
- 25. Defendant Custodian of Records for the DoE is named herein in his/her official capacity.
- 26. Defendant N.J. Department of Law and Public Safety, Division of State Police ("NJSP") is a public agency subject to the requirements of OPRA, and the common law right of access. See N.J.S.A. 47:1A-1.

- 27. Solomon is the Custodian of Records for the NJSP. Solomon is named herein in his official capacity.
- 28. The actions of the Defendants constitute denials of access to government records which may be challenged by way of a summary action to this Court pursuant to N.J.S.A. 47:1A-6.

STATEMENT OF FACTS

- 29. For the past several years, Plaintiff has filed OPRA requests with numerous public agencies seeking copies of prior OPRA requests submitted to the agency, and the agency's response thereto ("OPRA Records").
- 30. In some cases, Plaintiff requested the OPRA Records in his own name, and in other cases Plaintiff requested the OPRA Records anonymously. OPRA permits anonymous OPRA requests, see N.J.S.A. 47:1A-5i; the only limitation being access to certain personal information pertaining to a victim, or a victim's family, see N.J.S.A. 47:1A-2.2. These OPRA Records are identifiable government records, and absent a showing of exemption, privilege or undue burden on the public agency, the OPRA Records must be produced.
- 31. In the past, the public agencies have complied with their obligations under OPRA and the common law right of access, and granted Plaintiff's requests. See Exhibit A.
- 32. Recently, however, following the request for and release of "Bridgegate" documents, certain public executive agencies have denied Plaintiff's requests for OPRA Records:
 - a. On February 10, 2014, Plaintiff requested from the Office of the Governor a copy of all "OPRA requests submitted to this office in January 2014" and all "OPRA requests submitted to this office concerning the closure of George Washington Bridge lanes from September 1, 2013 until today's date." See Exhibit B. The request was denied on March 21, 2014. Id.

- b. On March 11, 2014, Plaintiff anonymously requested from the MVC a copy of all "OPRA requests submitted to MVC from 2/1/14 until 3/11/14." See Exhibit D. The request was denied on March 21, 2014. Id.
- c. On March 19, 2014, Plaintiff anonymously requested from the ABC a copy of all "OPRA requests submitted in the past 90 days."

 <u>See Exhibit E.</u> The request was denied on March 28, 2014. <u>Id.</u>
- d. On March 19, 2014, Plaintiff anonymously requested from the MVA a copy of all "OPRA requests submitted in the past 90 days." See Exhibit F. The request was denied on March 31, 2014. Id.
- e. On March 19, 2014, Plaintiff anonymously requested from the Treasury a copy of all "OPRA requests submitted in the past 90 days." See Exhibit G. The request was denied on March 31, 2014. Id.
- f. On March 19, 2014, Plaintiff anonymously requested from the DCA a copy of all "OPRA requests submitted in the past 90 days."

 <u>See Exhibit H. The request was denied on March 31, 2014. Id.</u>
- g. On February 26, 2014, Plaintiff requested from the DoE a copy of all "OPRA requests submitted in January 2014." See Exhibit I. The request was denied on April 1, 2014. Id.
- h. On March 21, 2014, Plaintiff requested from the MVC a copy of all "OPRA request forms submitted to MVC in 2014." See Exhibit J. The request was denied on April 1, 2014. Id.
- i. On March 20, 2014, Plaintiff requested from the NJSP a copy of all "OPRA requests made in 2013 and 2014 to the NJSP (requests only not documents released)." See Exhibit K. The request was denied on April 9, 2014. Id.
- 33. The above actions by Defendants constitute unlawful denials of access under OPRA, and the common law right of access.

COUNT ONE

(Violation of OPRA - Denial of Access)

- 34. Plaintiff hereby repeats and realleges the allegations in the preceding paragraphs as if more fully set forth herein.
- 35. Pursuant to OPRA, public agencies shall permit a government record to be inspected, examined, and copied by any person during regular business hours unless a government record is exempt from public access by statute, resolution, regulation, executive order, rules of Court, or federal law, regulation or order. N.J.S.A. 47:1A-5a.
- 36. Government records are defined by OPRA as those records that are maintained or kept on file in the course of official business by any officer, commission, agency or authority of the State or of any political subdivision thereof, including subordinate boards thereof, or that has been received in the course of official business by any such officer, commission, agency, or authority of the State or of any political subdivision thereof, including subordinate boards thereof. N.J.S.A. 47:1A-1.1.
- 37. Plaintiff requested access to OPRA Records from Defendants pursuant to N.J.S.A. 47:1A-5.
- 38. These OPRA Records are government records as that term is defined by N.J.S.A. 47:1A-1.1 because they are maintained or kept on file in the course of official business by Defendants.
- 39. The Defendants denied Plaintiff access to the OPRA Records, improperly alleging that they are exempt from disclosure.

- 40. No statute, resolution, regulation, executive order, rules of Court, or federal law, regulation or order exempts copies of OPRA requests and a public agency's response thereto from disclosure.
- 41. The actions of Defendants are in violation of their obligations under OPRA.
- 42. Plaintiff's and the public interest have been damaged, and continue to be damaged, by these actions.

COUNT TWO

(Violation of OPRA - Untimely Response)

- 43. Plaintiff hereby repeats and realleges the allegations in the preceding paragraphs as if more fully set forth herein.
- 44. OPRA requires public agencies to "grant access to a government record or deny a request for access to a government record as soon as possible, but not later than seven business days after receiving the request, provided that the record is currently available and not in storage or archived." N.J.S.A. 47:1A-5i.
- 45. In violation of OPRA, Defendants Office of the Governor and McNally requested two extensions of time to respond without any justification, and ultimately denied Plaintiff's request on March 21, 2014 more than seven business days after receiving Plaintiff's request, dated February 10, 2014.
- 46. In violation of OPRA, Defendants MVC and Bruno denied Plaintiff's request on March 21, 2014 more than seven business days after receiving Plaintiff's request, dated March 11, 2014.

- 47. In violation of OPRA, Defendants MVA and Preston denied Plaintiff's request on March 31, 2014 more than seven business days after receiving Plaintiff's request, dated March 19, 2014.
- 48. In violation of OPRA, Defendants Treasury and Jablonski denied Plaintiff's request on March 31, 2014 more than seven business days after receiving Plaintiff's request, dated March 19, 2014.
- 49. In violation of OPRA, Defendants DCA and Campanelli denied Plaintiff's request on March 31, 2014 more than seven business days after receiving Plaintiff's request, dated March 19, 2014.
- 50. In violation of OPRA, Defendants DoE and Defendant Custodian of Records for the DoE denied Plaintiff's request on April 1, 2014 more than seven business days after receiving Plaintiff's request, dated February 26, 2014.
- 51. In violation of OPRA, Defendants NJSP and Solomon denied Plaintiff's request on April 9, 2014 more than seven business days after receiving Plaintiff's request, dated March 20, 2014.
- 52. The actions of Defendants are in violation of their obligations under OPRA.
- 53. Plaintiff's and the public interest have been damaged, and continue to be damaged, by these actions.

COUNT THREE

(Common Law Right of Access)

54. Plaintiff hereby repeats and realleges the allegations in the preceding paragraphs as if more fully set forth herein.

- 55. The public enjoys a common law right of access to public records generated or maintained by public entities. See, e.g., Keddie v. Rutgers, 148 N.J. 36 (1997); S. Jersey Publ'ing Co. v. N.J. Exp'way Auth., 124 N.J. 478 (1991).
- 56. Defendants generate, maintain, or have received the requested public records that are "necessary to be kept in the discharge of a duty imposed by law" (among other possible qualifying conditions). S. Jersey Publ'ing Co., 124 N.J. at 487.
- 57. There is a strong public interest in favor of disclosing the requested records, and no overriding, countervailing interest in maintaining their confidentiality.
- 58. Plaintiff and the public alike have an interest in knowing whether Defendants are complying with OPRA and other open public records laws.
- 59. Accordingly, Defendant's failure to disclose the requested public records violated Plaintiff's common law right of access.
- 60. Plaintiff's and the public interest have been damaged, and continue to be damaged, by these actions.

WHEREFORE, Plaintiff demands judgment against Defendants:

- a. Declaring Defendants in violation of OPRA and the common law right of access;
- b. Compelling Defendants to immediately provide access to all of the requested records;
- c. Maintaining jurisdiction over this action until Defendants come into compliance with the Court's directives and Orders;
- d. Granting attorney's fees and costs of suit pursuant to N.J.S.A. 47:1A-6; and

ALL OPRA requests submitted to this office concerning the closure of George Washington Bridge lanes from September 1, 2013 until today's date. Please release all documents with the OPRA requests.

Please be advised that other requesters' OPRA requests are exempt from disclosure under OPRA, as are the responses of government agencies to those OPRA requests. The Appellate Division has recognized that there is an "interest of third parties in protecting the confidentiality of their requests for access to public documents" under OPRA. Gannett N.J. Partners, LP v. Cnty. of Middlesex, 379 N.J. Super. 205, 212 (App. Div. 2005). For that reason, "OPRA does not authorize a party to make a blanket request for every document a public agency has provided another party in response to an OPRA request," nor does it permit requests that would reveal "the nature and scope of a third party's inquiry to a government agency." Ibid. Further, OPRA exempts "information which, if disclosed, would give an advantage to competitors." N.J.S.A. 47:1A-1.1.

One of the most useful documents a budding FOIA requester can seek is <u>a log of FOIA requests</u> submitted to a particular agency, which under federal law are considered public records. As with so many other things, however, the situation is very different in New Jersey.

A few weeks ago, I requested a log of all requests filed under the state's Open Public Records Act with the Office of the Governor in fiscal year 2013. Gawker, where I work, had just received a tip about a video that

appeared to depict Governor Chris Christie engaged in various sex acts—<u>it turned out to be bunk</u>—and I wanted to see if any other reporters were already sniffing around.

Last week, the governor's office issued <u>a total denial</u> of the requested logs, citing both a 2005 opinion issued by a state appellate court as well as brief provision in O.P.R.A.'s text concerning "information which, if disclosed, would give an advantage to competitors or bidders":

The Appellate Division has recognized that there is an "interest of third parties in protecting the confidentiality of their requests for access to public documents" under OPRA. (Gannett N.J. Partners, LP v. Cnty. of 379, N.J. Super. 205, 212 App. Div. 2005). For that reason, "OPRA does not authorize a party to make a blanket request for every document a public agency has provided another party in response to an OPRA request," nor does it permit requests that would reveal "the nature and scope of a third party's inquiry to a government agency." Ibid. Further, OPRA exempts "information which, if disclosed, would give an advantage to competitors," (N.J.S.A 47:1A-1.1), such as the disclosure of matters being investigated by news organizations to potential competitors of those news organizations.

It is not clear how, exactly, the cited opinion applies to my request for the office's 2013 OPRA log, as it concerns the confidentiality of communications between a state agency and the U.S. Attorney's office, and only off-handedly refers to news outlets asking for communications between an agency and other news outlets.

"Suppose Gannett suspected that another news organization was conducting an investigation into a public agency's financial practices and had sought production of documents under OPRA in connection with that investigation," writes Judge Stephen Skillman. "Could Gannett make a blanket request to the public agency for the production of all records provided to the other news organization?" Skillman never answers this question.

The OPRA provision invoked by the Office of the Governor is slightly trickier to parse. The <u>text of the law</u> considers "information which, if disclosed, would give an advantage to competitors or bidders" to be confidential, and so exempt from disclosure. Under the Office of the Governor's interpretation, fulfilling my request would provide an advantage to me since I work for a news outlet and requested records that would reveal other outlets' OPRA requests.

This raises a number of questions: What is the criteria for determining "advantage"? Would the request have been treated differently if I had not identified myself as a reporter?

Under the Office of the Governor's interpretation, agencies are asked to comply with O.P.R.A. yet allowed to completely shield how they do so, and who is requesting which records, from public view. Unlike F.O.I.A., New Jersey's Open Public Records Act doesn't extend to itself.


