HOW TO MAIL YOUR POSTCARDS SO THEY REACH THOSE IN POWER

The U.S. Supreme Court has overturned *Roe v. Wade*, dismantling the constitutional protections for abortion that have existed for nearly 50 years. This moment calls for urgent, bold, and collective action.

Tell the New Jersey Legislature: We need abortion access for all, and we won't accept anything less. New Jersey must immediately advance and sign **A4350/S2918** into law.

To make sure your voice is heard, affix a stamp and include your name and ZIP code on the card prior to mailing.

Earlier this year, New Jersey took action by codifying the right to reproductive autonomy, including the right to abortion. But this right continues to be in name only for far too many, including low-income, undocumented, and under- and un-insured people.

We can't afford to stay quiet when our fundamental rights and freedoms are on the line. That's why we won't stop fighting until abortion care isn't just legal, but accessible and affordable for all in New Jersey.
